Business Highlight

PTC is the first independent oil depot listed on the stock market and the most modern energy hub in the northeastern region. It provides services for receiving, storing, blending, and distributing fuel according to customer specifications, with a network of two oil depots in Khon Kaen and Sisaket provinces to distribute fuel oil to gas stations covering the entire northeastern region.

In addition to the oil business, PTC also develops clean water filtration innovations to enhance community well-being. Through its subsidiary, which researches and advances modern clean water solutions, ensuring that communities facing water scarcity have sustainable access to safe and clean water.

Performance and Analysis

Business Performance Summary

In the first half of 2026, the Company posted a net profit of THB 2.76 million, down 39.67% YoY, primarily due to the temporary suspension of the Si Sa Ket depot after contract expiry. The impact was mitigated through structural cost optimization (Lean Expenses), driving a 43.75% YoY reduction in service costs. Administrative expenses rose slightly by 1.32% YoY from fixed costs to maintain the depot, including security, essential utilities, and depreciation. As most of the increase was depreciation, a non-cash item, cash flow and liquidity remained unaffected

Financial status The Company maintained a solid financial structure with a current ratio of 103.39 times and a D/E ratio of 0.016 times. These figures underscore low debt obligations and readiness to support future business expansion.

The Company is pursuing a new S-Curve in the utilities sector through community water supply systems, while negotiating with prospective clients to utilize the Si Sa Ket oil depot. Concurrently, feasibility studies on potential investments are underway to diversify financial risks and expand the revenue base, supporting stable and sustainable long-term growth.

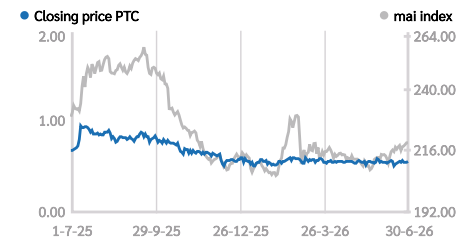
Risk from reliable on major customers : The Company manages this risk by controlling service quality, maintaining good relationship with existing customers, and seeking for new customers.

The Company's insurance has covered all potential damage and renew insurance every year.
